

**TOWNSHIP OF EVESHAM**

**ORDINANCE NO. 18-9-2018**

**AN ORDINANCE MAKING THE PROVISIONS OF SUBTITLE ONE OF TITLE 39 WITH VARIOUS TRAFFIC REGULATIONS APPLICABLE TO BARTON RUN BOULEVARD, EVESHAM TOWNSHIP, BURLINGTON COUNTY, NJ, AND REGULATING THE USE OF SAID ROADWAYS, STREETS, DRIVEWAYS AND PARKING LOTS BY MOTOR VEHICLES**

**NOW, THEREFORE**, be it Ordained by the Township Council of the Township of Evesham that the provisions of Subtitle One of Title 39 of the revised statutes of New Jersey for Various Traffic Regulations to be made applicable to the semi-public roads, streets, driveways and parking lots along Barton Run Boulevard located in the TOWNSHIP OF EVESHAM, COUNTY OF BURLINGTON; and the following regulations shall be enforceable based on the 'Title 39 Compliance Plan, Barton Run Boulevard', bearing a date of March 19, 2018 , signed July 26, 2018:

**SECTION 1:** Chapter 150 of the Code of the Township of Evesham is hereby amended to add the following:

**§ BARTON RUN BOULEVARD**

It has been requested that the provisions of Subtitle One of Title 39 of the Revised Statutes of New Jersey be made applicable to the semipublic roads, streets, driveways, and parking lots on Barton Run Boulevard located in the Township of Evesham, County of Burlington, and the following regulations shall be enforceable:

- A. §150-6 Parking prohibited at all times.  
a. Schedule I (§150-32) shall be amended to add the following:

<b>Name of Street</b>	<b>Sides</b>	<b>Hours</b>	<b>Location</b>
Barton Run Boulevard	Both	All	(1)

- (1) All vehicles must park in designated areas and between lines provided as designated on the plan referenced above and on file with the Clerk's Office.

- B. §150-8. Stopping and standing prohibited.  
a. Schedule III (§150-34) shall be amended to add the following:

<b>Name of Street</b>	<b>Sides</b>	<b>Hours</b>	<b>Location</b>
Barton Run Boulevard	Both	All	(1)

- (1) All vehicles must park in designated areas and between lines provided as designated on the plan referenced above and on file with the Clerk's Office.

- C. §150-27 Limits established.  
a. Schedule XVII (§150-48) shall be amended to include the following:

- (1) The speed limit for both directions of travel on the following roadways are:

<b>Name of Roadway</b>	<b>Speed Limit (mph)</b>	<b>Limits</b>
Barton Run Boulevard	25	Entire Length

- D. §150-31 No-passing zones established  
a. Schedule XIX (§150-50) shall be amended to include the following:

Barton Run Boulevard Between Jessica Court and Taunton Lake Road	None Required	None Required

**SECTION II. REPEALER**

All Ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION III. INVALIDITY**

If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this ordinance shall be deemed valid and effective.

**SECTION IV. EFFECTIVE DATE**

This Ordinance shall take effect 20 days after its proper publication after final passage as required by law.
