SEALED BIDS WILL BE RECEIVED BY THE TOWNSHIP OF EVESHAM FOR:

2021 TRIPLE-A SUMMER CAMP LUNCH PROGRAM

Due to the directive from the State to limit public gatherings, bidders will not be able to attend the on-site opening, but will be invited to attend via Zoom. Proposals shall be submitted by mail or in person. Bid proposals will be opened and read aloud via the Zoom meeting on April 14, 2021 at 11:00 AM. Bidders bear sole responsibility for ensuring that their bids are received by the Township prior to the time stated for receipt of bids, and that bidders are responsible for ensuring accuracy completeness and accessibility by the Township. **Electronic submissions of Bids will not be accepted.**

Bid specifications and proposal forms may be obtained from the Township of Evesham, Department of Finance, Municipal Complex, 984 Tuckerton Road, Marlton, New Jersey, Monday through Friday 8:30 a.m. – 4:30 p.m.

Bids must be made on the Township's proposal form and must be enclosed in a sealed envelope prominently bearing the name and address of the bidder and the name of the project "**2021 TRIPLE-A SUMMER CAMP LUNCH PROGRAM**" on the outside addressed to the Township of Evesham, Office of the Township Clerk, Municipal Complex, 984 Tuckerton Road, Marlton, New Jersey 08053. Bids shall be accepted no later than 11:00 AM at the Township Clerk's office, Room 201.

The Township will not assume responsibility for bids mailed in.

All bids must be accompanied by a certified check, cashier's check or bid bond for not less than ten percent (10%) of the total price bid, but not to exceed \$20,000.00 and be made payable to the Township of Evesham and be delivered to the place and by the hour above named.

Bidders shall submit with the bid a Certificate (Consent of Surety) with Power of Attorney for full amount of bid price from a Surety Company authorized to do business in the State of New Jersey and acceptable to the owner stating that it will provide said bidder with a Performance Bond of \$30,000.00. Failure to submit a consent of surety form shall result in rejection of the bid.

The Township reserves the right to accept or reject any or all bids, to waive technical defects and make the award to the bidder most competent to serve the Township's requirements.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et. seq., N.J.S.A. 17:27 (Affirmative Action), and Americans with Disabilities Act of 1990 (42 U.S.C. 12101, et.seq.).
