## ANNUAL INSURANCE REQUIREMENTS & REGISTRATION

PER CHAPT.60B (ORDINANCE NO. 11-6-2023)

Pursuant to the provisions of New Jersey P.L. 2022, c. 92 and Chapter 60B of the Evesham Township Code:

All Evesham Township owners of rental units, and owners of owner-occupied multi-family units are required to annually maintain certain liability insurance minimums and <u>to</u> register proof of insurance with the Evesham Township Clerk's Office.

- a) All rental unit owners (except as provided in section (b) below) are required to maintain liability insurance for negligent acts and omissions, at a policy minimum of \$500,000 for combined property damage and bodily injury to, or death of, one or more persons in any one accident or occurrence
- b) Owners of multi-family dwellings with four or fewer units, of which one unit is owner-occupied, must maintain liability insurance for negligent acts and omissions, at a policy minimum of \$300,000 for combined property damage and bodily injury to, or death of, one or more persons in any one accident or occurrence.

NOTE:

If an owner fails to maintain the required level of insurance or fails to file annual registration, the Township may impose a fine against the owner of not less than \$500 but no more than \$5,000 by way of summary proceeding pursuant to N.J.S.A. 2A:58
