RESOLUTION NO. 95-2026

RESOLUTION DIRECTING THE EVESHAM ENVIRONMENTAL COMMISSION TO  
ESTABLISH A GREEN TEAM ADVISORY SUBCOMMITTEE

WHEREAS, by Resolution 259-2010, the Township of Evesham ("Township") established the Green Team Advisory Committee to lead and coordinate the sustainable activities of the community; and

WHEREAS, through the efforts of the Green Team Advisory Committee, the Township has been certified as a Sustainable Jersey silver community; and

WHEREAS, the Evesham Environmental Commission is authorized by Chapter 6 of the Evesham Township Code to have all the powers and duties set forth in N.J.S.A. 56A-1 et seq.; and

WHEREAS the power and duties of the Evesham Environmental Commission are consistent with those of the Green Team Advisory Committee; and

WHEREAS in order to ensure the efficient and consistent advisement on conservation, preservation and sustainability within the township of Evesham, the Mayor and Council believe that the Green Team Advisory Committee can best serve the Evesham Township community as a subcommittee of the Evesham Environmental Commission.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Evesham, County of Burlington, State of New Jersey, that:

1. Township Council directs the Evesham Environmental Commission to establish the Green Team Advisory Subcommittee that shall consist of no more than 9 members to be appointed by the Mayor to serve without compensation; and

2. Membership of the Green Team Advisory Sub-Committee shall be comprised as follows:
  - a. The Township Manager or his/her designee;
  - b. At least one member of the Environmental Commission;
  - c. A member of Township Council
  - d. Up to 6 members of the community, appointed by the Mayor.
3. The Mayor shall designate the member of Council and the member of the Environmental Commission, and appoint all community members of the Green Team Advisory Sub-Committee. A majority of the appointed members shall constitute a quorum. All members, except for the Township Manager or his/her designee, shall be residents of Evesham Township during their entire term of service. All members shall be over the age of 18.
4. The initial term of the community members shall expire on December 31, 2027.
5. Each member shall serve for a one-year term after the initial term set forth in paragraph 4 expires.
6. The Green Team shall meet regularly. A member of the Environmental Commission shall serve as the Chairperson of the Green Team, who shall preside over all meetings of the Green Team. Where more than one member of the Environmental Commission serves on the Green Team, the Chairperson of the Environmental Commission shall designate who serves as the Chairperson of the Green Team. The Chairperson of the Green Team shall select a vice-Chair to preside over meeting in the absence of the Chairperson. At the first meeting of each year the Green Team Advisory Subcommittee shall establish a list of its meetings for the year, and immediately following that meeting, the Chairperson shall provide that schedule to the Township Clerk for publication.

7. The Green Team shall strive to work with representatives of the Evesham Township Community to provide advisement regarding Evesham Township's participation in the Sustainable Jersey program, and to educate and encourage all Township employees, residents, and businesses to participate in green initiatives, and to collaborate with public and private green communities to ensure a coordinated effort within Evesham Township and neighboring communities.
8. The Green Team Advisory Sub-Committee shall be strictly an advisory body with no power to regulate or promulgate rules and regulations. All Green Team initiatives and events must obtain the support of the Evesham Environmental Commission and must receive the prior written authorization of the Township Manager. Without such authorization from the Township Manager, Green Team members shall not advocate for policies on behalf of the Green Team, Township nor Environmental Commission.
