600 Marlton Pike West, Block 23, Lots 2.01 & 2.02 (C-2/EVOC Zone district) Application is proposing a 3,960 sq. ft. car wash building on an existing inventory parking lot for the Burns Buick GMC dealership.

A Steven Fabietti, Attorney for the Applicant.

Steven Fabietti Attorney for applicant, Peter Lanzavecchia (President/Operations for Burns Buick GMC, Inc.) presented a summary of the requested variance to construct a car wash to detail cars.

At present the property in question is used for car storage. It is in the C2 district within the Evesham overlay.

Peter Lanzavecchia (President/Operations for Burns Buick GMC, Inc.) Peter Lanzavecchia (President/Operations for Burns Buick GMC, Inc.) described car preparation in detail.

Mr. Plante -Licensed Professional Planner and Civil Engineer was introduced by A. Steven Fabietti. Mr. Plante presented testimony.

Described existing conditions at the car storage lot.

Mr. Plante anticipates that if the variance is approved, the applicant will:

Develop under-utilized property.

Structure will sit 185' from closest resident.

The lot's proximity is convenient to dealership.

Reduce 400 roundtrips per month to take the cars to a local car wash.

The clientele expects this service when their cars are in for maintenance.

The car wash will be used for routine new vehicle preparation as well.

The 5.5 acre site could be used for an Office Building which would be possibly more undesirable than its present or proposed use.

Proposed footprint of the car wash structure.

Topography would be screened by fence and evergreens.

Wash bays are quieter than service bays.

All equipment is in an "enclosed door system"

Noise: When one is 30' from closed building and wash is in use, the noise decibels should be registering at 68-76.

None of the bays at the car wash will be used for Mechanical service on any of the vehicles at the dealership.
