Lisa Drahorad – Bulk Variance ZB 14-01

2245 Old Marlton Pike Block 17, Lot 4.02 (LD Zone District) Applicant is requesting a bulk Variance to permit farm animals on a lot that is less than the area required for agricultural use.

Ms. Drahorad, sworn in.

Ms. Drahorad has applied for a Bulk CI variance to allow 2 horses and 1 sheep on the property. This property has continually had animals. It is fenced in and has a barn. The horses see a vet every 5 weeks. The zoning is LD zone district. Agriculture use must meet minimum setbacks.

Nancy Jamanow, Director of Community Development report dated February 13, 2014. Agriculture is a permitted use in the LD Zone on a lot of 6 acres or more. This lot is 1.13 acre lot. The applicant has 2 horses and 1 sheep on the property. The Township follows the recommendations contained in the "Recommended Guidelines for Home Animal Agriculture in Residential Areas" prepared by Rutgers, the State University of New Jersey. This document recommends that not more than 1 horse shall be kept on the first acre of land. This document recommends 5 sheep are allowed on 1 acre of land. Page 3 Minutes 24 February 2014

Ms. Drahorad – there was an existing barn and added a 10 x 19 3-sided shelter. The barn is A-frame square building open on 2 sides. The property was bought in 2000 and had 2 horses at that time. Waste from animals is removed every month in the summer. There is a fence with 4 x 4 posts and also is electric wired. Never received a zoning permit only a complaint. Other houses in area have horses, donkeys, peacocks and chickens. Will follow the guidelines from the Township which is the "Humane Standard for Livestock".

Public Portion Carolyn Marshall Tomlinson Mill Road, sworn in. Has 3 acres of land on Tomlinson Mill Rd.; 1 acre is fenced in for a horse.

Peter Foster 2241 Old Marlton Pike sworn in. Has lived next to Ms. Drahorad for 13 years and has made the complaint; he has a horse that is boarded. All summer manure is permeates the air and there are black flies and mosquitos. The manure is not being cleaned up. The place is always flooded out.

Mrs. Jamanow has read the Rutgers manure procedures.

Applicant agreed to follow the manure removal schedule as a condition of approval.

Mr. Foster – there is a water problem.

Nathan Supnick, Hartford Rd. Medford, sworn in.

Has 30 acres of land and has 14 horses. Ms. Drahorad took a sick horse and after got better he was sent back to Mr. Supnick. Horses cannot exist alone should have another horse.

Linda Foster – 2241 Old Marlton Pike, sworn in.

The manure is never cleaned out except for last weekend. Yard smells so bad with manure and urine; they cannot sit on the deck.

Ms. Drahorad – horses are healthy; a drainage ditch was put in by the Township.

Exhibit A6 – undated, Mr. Horner removed manure letter.

Closed Public Portion.

Matthew Wieliczko, solicitor -2 horses are allowed and 1 sheep. If one of the horses dies he cannot be replaced.
