# **ECF Events Only:**

- Purpose of events is to revitalize Main Street.
- Operations plan is on file and will be approved by the Evesham Township Police Department and the Evesham Township Fire Department.
- Applicant expects approximately 5,000-6,000 attendees for the Taste of Evesham. Event will go from 8am to 6pm. Street closures include Maple- Locust. Applicant will provide an ABC liquor license for event.

- July 4<sup>th</sup>: Parade/5k Run will go from 7am-3:30pm. Street closures will be from Route 73 to Evans Road. Fireworks will be on display at Cherokee High School at night.
- Harvest Fest: Hours will be from 8am to 6pm. Street Closures will be from Maple to Beetlewood. No intent to serve alcohol.
- Winterfest: will be located at Main Street Fire House. No intent to serve/sell alcohol.
- ECF will provide insurance to the Township Solicitor, which will be reviewed before each scheduled event.

# MBA Events Only:

- Applicant gives brief description of the event. Used to be the Marlton Business Expo, is now renamed Marlton Day. Will also take place on Main Street as was the location last year.
- Event will showcase local businesses, nonprofits, crafters, and food for purchase.
- Purpose of event is to revitalize businesses and Main Street.
- Expecting approximately 2,500 attendees.
- Applicant will provide liability insurance to the Township Solicitor.
- Road closures will be from Locust to Maple Avenue.
- Location of the vendors will be similar to what is seen during Harvest Festival.
- Applicant states there is no construction needed for this event, nor will alcohol be served.
