

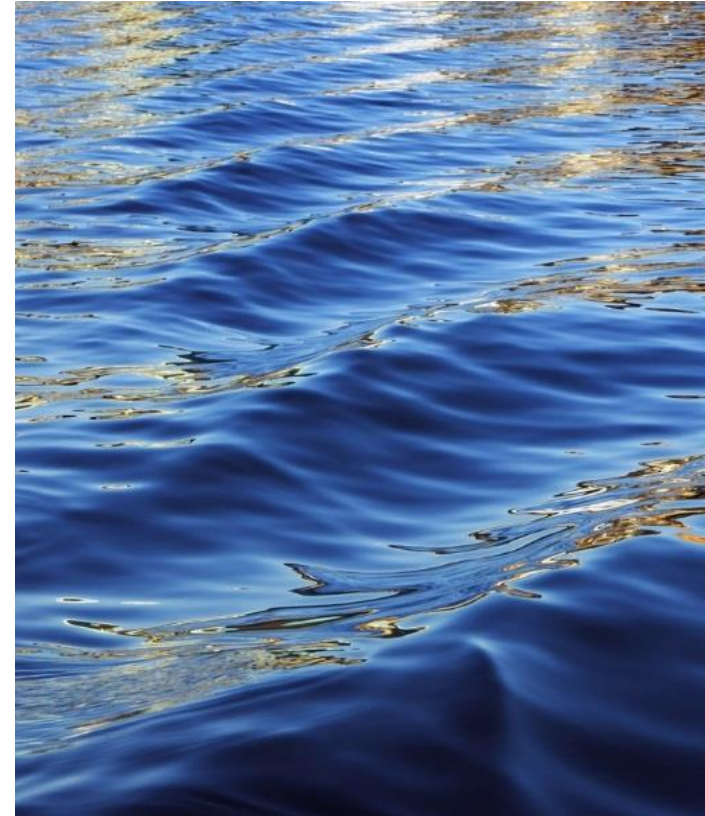

# EEC Accomplishments 2021

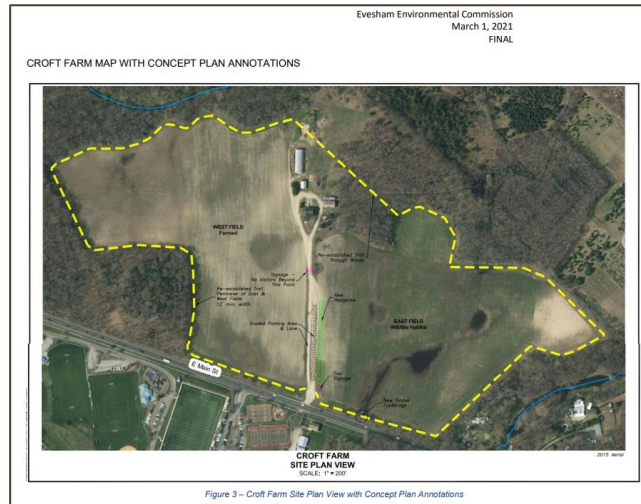
## Policy

- Helped to write enhanced regulations for the township's Stormwater Control Ordinance (non-Pinelands); these were adopted by the township
- Reviewed and commented on the Stormwater Management Plan element of the township's Master Plan
- Submitted draft changes to the township's recommended tree list, modified to remove invasive and non-native trees
- Performed some preliminary research into the recent NJ law that requires the land use plan element of a municipal Master Plan to include a climate change-related hazard vulnerability assessment

45 species of birds reported by local birders in October and highlights included:

- Eastern Meadowlark in the east field\*
- Pipit overhead
- 1 Rusty Blackbird: high flyover, calling\*
- 1 American Kestrel\*
- 7 Savannah Sparrow in the east field\*
- 7 Field Sparrow
- 3 Blackpoll Warbler
- 60 Yellow-rumped Warbler

### \*NOTES:

Eastern Meadowlark is species number 144 for Croft Farm.

Eastern Meadowlark is a **Special Concern (breeding)** on the NJ Endangered and Threatened Species Field Guide.

Savannah Sparrow is **Threatened (breeding)** on the NJ Endangered and Threatened Species Field Guide.

American Kestrel is **Threatened** on the NJ Endangered and Threatened Species Field Guide.

Rusty Blackbird is described as "...one of North America's most rapidly declining species." by the Cornell Lab

# EEC Accomplishments 2021

- Councilwoman Hansen received an ANJEC award for exceptional environmental stewardship by a township official
- Organized and ran the Tree Give Away at Laurel Oak
- Worked with Rutgers on the planned rain garden behind the Blue Barn
- Kept apprised of the Ellis Site clean up and the Owens Corning Berlin site
- Grants
  - Completed the ANJEC Open Space grant and submitted final report
  - Supported the submission of the ACE Sustainable Communities grant for 2021; township received the grant
- With the guidance and support of our Watershed Ambassador, completed three stream assessments
- Provided informational posts for township's social media
- Submitted a 2022 budget
