An Ordinance to Amend Chapter 161 Zoning Modifications and Additional Requirements, Section 161-1 Conditional Uses

Ordinance creates two alternatives/standards for conditional use for Route 73 south of Evesham Road and Marlton Parkway.

In the past, "Fast food and drive thru" restaurants had to be attached to a shopping center.

Some land use variances have been granted for free standing fast foods in the township. Proposal to keep standards- but allow "fast Food" to be free standing in a 2.5 acre site.

Ordinance will provide :

Free standing venues And other conditions outlined in ordinance C-1 zoning Not in EVCO Safe usage is paramount Not inconsistent with Master Plan
